WHEREAS, it has been determined by the Ross County Board of Commissioners that the health, welfare and safety of the people of Ross County, Ohio, can best and most efficiently be served by force account in matters pertaining to the maintenance, repair, construction and reconstruction of roads, bridges and culverts in Ross County, Ohio; now, therefore, be it

RESOLVED, that Charlie Ortman, Engineer of Ross County, Ohio, be and he hereby is authorized to employ labor and proceed by force account in matters pertaining to the maintenance, repair, construction and reconstruction of roads, bridges and culverts in Ross County, Ohio during the calendar year 2024; and, be it further

RESOLVED, that the Board of Commissioners of Ross County, Ohio, reserves unto itself the right and authority to make all purchases of materials and equipment required in the maintenance, repair or construction of roads, bridges and culverts in Ross County, Ohio, during calendar year 2024, except under certain circumstances when the Board may, from time to time by resolution, delegate such purchasing authority to the Ross County Engineer.

MEMORANDUM OF UNDERSTANDING 2024 COST PROJECTION JFS

Mr. Lowe moved, Mr. Everson seconded, to enter into a memorandum of understanding between the Board of Commissioners of Ross County, Ohio and South Central Ohio Job & Family Services (SCOJFS) primary contact for claims management of Ross County's Workers' Compensation. South Central Ohio Job & Family Services will serve as the primary contact for the TPA (Comp management) for Ross County's Workers' Compensation program. SCOJFS will work with the TPA and the Board of Commissioners of Ross County on certification problems and appeals that require in depth investigation at a projected cost of \$7,519.00
