RESOLUTION 023-24

WHEREAS, The Ross County Board of Commissioners actively supports and currently participates in the economic development district activities of the Ohio Valley Regional Development Commission (OVRDC). OVRDC is a public regional planning commission within the State of Ohio, whose purpose is to influence favorably the future economic, physical, and social development of the twelve-county region through its regional development planning programs and technical assistance; and

WHEREAS, the Ohio Valley Regional Development Commission promotes a cooperative planning process involving local governments, public and private agencies, and individual citizens, toward improving their region within a democratic process; and

WHEREAS, the Ross County Board of Commissioners hereby endorses the 2022 Comprehensive Economic Development Strategy (CEDS), prepared by the Ohio Valley Regional Development Commission.

THEREFORE, BE IT RESOLVED, that the Ross County Board of Commissioners hereby authorizes an appropriation of funds in the amount of \$7,650.00 as participating local funds for the Ohio Valley Regional Development Commission to be used as part of the agency budget for the fiscal year beginning January 1, 2025. The appropriated funds to be paid on or after January 1, 2025, and

NOW, THEREFORE, BE IT FURTHER RESOLVED, the Ross County Board of Commissioners continues to support the Ohio Valley Regional Development Commission's Economic Development District planning partnership investment grant program with the USDOC Economic Development Administration for the annual performance period January 1, 2025 through December 31, 2025.

Ms. Heidi Carter discussed the Law Library and the difficulty finding someone there to allow entry. Ms. Carter stated there are no business hours listed, making it difficult to be able to use their services.

Auditor Lehner discussed his plan to do revaluations on properties in Ross County. He stated the last time a revaluation was done was in 2007. This will help to close the gap between the commercial and residential property values. The increased tax would be phased in over a period of time so as not to over burden the property owners with a sizeable increase all at once. Auditor Lehner also discussed reducing the 3.1 mil property tax. The Commissioners are not in favor of reducing taxes at this time do to the infrastructure projects they have planned.
